### **Important points to be kept in mind by the applicant, for filling up the application form for YJCCI Membership**

1. The applicant should fill the form in clear and legible writing.
2. In case the office address is provided by the applicant, it is compulsory to provide the proof of registration under Shops & Establishments Act, and if the factory/workshop address is provided, the copy of registration and license for the factory is compulsory.
3. In case the names of representatives are not mentioned in the certificate of registration, the applicant has to Submit a resolution on the Company's letterhead, duly certified by the authorized signatory or owner of the Company.
4. The Executive Committee reserves the right to cancel the membership of any member whose details are found to be incorrect at a later stage. The Executive Committee has the right to reject the application for membership without having to cite any reasons. Any applicant whose application has been rejected by the Executive Committee can reapply after a period of 2 years from the date of rejection of the application.
5. There cannot be more than 3 representatives from the same address, unless the Scrutiny Committee is satisfied as per YJCCI Constitution.
6. Service activities, Professional activities and Trading activities falling under the non industrial category i.e. Hospitality, Entertainment, Education, Medical Practitioners, Petrol / Diesel sale and other similar activities are not eligible for YJCCI membership.
8. The applicant needs to submit along with the application form two passport sized/stamp sized photographs of each representative, with names written at the back.
9. The applicant needs to submit details of whether the enrolment fee and annual fee has been paid from his own bank/firm or company owned by him, in a covering letter signed by him. Applicants in the mofussil category need to get a pay order and attach the pay order slip along with a covering letter signed by him.
10. The member will cease to be a member after six months of the closure of his business.
